International Recovery Platform

Implementation of the Hyogo Framework for Action declared at the World Conference on Disaster Reduction

Background

Launched in May 2005 in Kobe-Hyogo as a follow-up to the World Conference on Disaster Reduction (WCDR) under the initiative of UNDP, UN/OCHA, UN/ISDR and ILO, with the support and encouragement of Government of Japan (including Hyogo Prefectural Government) and in close collaboration with ADRC, the International Recovery Platform (IRP) is a mechanism in line with the Hyogo Framework for Action (HFA) 4(ii)(h)*. It seeks to fulfill the strategic goal (c)** of the HFA by functioning as an international repository of knowledge and as a networking mechanism for recovery, aiming to address the gaps and constraints inherent in the current contexts of recovery.

Gaps and Constraints in the current context

- Post-disaster recovery often leads to rebuilding risk.
- Support to recovery operations by various organizations is often coordinated inappropriately, leading to a duplication of efforts and failure to factor in risk reduction.

Objectives of the IRP

Immediate objectives of the inception phase of the IRP are the following:

- > To translate into practice the strategic goal of integrating risk reduction into post disaster recovery as mandated in the HFA
- > To provide a coordination framework and network for post-disaster recovery
- > To facilitate the dissemination of lessons learned and the development of common tools and mechanisms
- > To provide advice and support on the formulation of post-disaster recovery planning and programming
- > To strengthen national capacities ensuring links with longer term development programming
- > To facilitate South-South co-operation between disaster-prone countries and to utilize the accumulated know-how of these countries

Priority Activities


The IRP focuses on the following three inter-related components:

- > Enhanced Recovery Operations

The systematic incorporation of risk reduction approaches into the design and implementation of emergency preparedness, response and recovery programmes in the reconstruction of affected communities



Outcomes

- > The IRP functions as an inter-agency network for taking forward the HFA in relation to reducing the underlying disaster risk through post disaster recovery efforts
- > The IRP is a thematic platform of UN/ISDR, reports to the General Assembly through the IATF/DR
- Matrix of roles and responsibilities of stakeholders including core members, relevant organizations and countries has been agreed at stakeholders meeting in Kobe, May, 2005
- Advocacy & Knowledge Management coordinated by ADRC & UN/ISDR from IRP Hyogo Office; agreed to include linkages to UN/OCHA, WB, ProVention, UN-Habitat, IFRC, ADPC, DRI, SDC and other case studies
- > Training & Capacity Building coordinated by ILO & UNDP/DMTP; have developed an on line inventory of global training resources relevant to post disaster recovery and will begin certifying courses for recovery managers
- ➤ Enhanced Recovery Operations coordinated by UNDP in cooperation with partners is focusing on developing joint assessment methodology. A draft TORs is being discussed by members of the Advisory Group
