Work Plan	Result 1.1
<p>UNISDR Advocacy and Outreach Section</p>	<p>The session of legislators and governance for disaster risk reduction was jointly organized by Inter-Parliamentary Union and UNISDR. We have gathered 31 parliamentarians from 27 countries and four regional parliamentary assemblies. The discussion focussed on governance for disaster risk reduction and obtaining the commitment of parliamentarians to the HFA2. Parliamentarians shared their views and experiences and agreed that parliamentarians should be recognized as important stakeholders. Parliamentarians play a critical role in consultations and implementation of the HFA. Parliamentarians agreed on the key elements of a successful governance of DRR: institutional frameworks, regulatory frameworks, legislation, oversight, transparency and accountability, and empowerment and inclusion. Participation in the advisory group provided an impetus for several actions on the part of parliamentarians:</p> <p>Awareness was raised on DRR among members of the parliament of Uganda, the MP from the UK has wrote to the Secretary of State for International Development on the role of the UK in the development of the successor to the Hyogo Framework for Action. The MP also asked the Secretary of State how the cabinet office's leadership on this process connects to DFID's role on HFA2, and also asked for details on the strategic links between development of the HFA2 and the post MDG process. Furthermore, details on the envisaged timetable for providing funding to civil society for resilience initiatives were requested. It was suggested that the Public Accounts Committee could assess how prepared the government is to deal with disasters and carry out a survey of resilience-increasing steps taken so far. He also had a meeting with the British Group of the International Parliamentary Union regarding the possibility of creating a Database of Best Practices for DRR. Additionally, Members of parliament substantively contributed to the Regional Platform meetings in Africa, Asia and the Americas.</p> <p>Global Platform: Online Systems and Website: The online registration system designed and developed by the Information Management Unit facilitated 5,639 applications and registration of 3,500 participants. This updated system ensured that all person profile information was captured in the UNISDR Contact Directory, contributing to our internal knowledge management. Additionally, a field trip registration system supported the Swiss in planning and organizing three field visits. The Global Platform Statement Management system was updated to improve efficiency in scheduling and communicating official oral statement delivery by National Delegates, selected stakeholder groups, and written statements of partners. 140 official statements were made. A corresponding video statement delivery platform automatically informed and delivered broadcast-ready statements to all in-country media contacts and disaster risk reduction organizations. The videos were also published on the UNISDR YouTube channel, with over 3500 views by the end of the Global Platform week. Many country statements had already been watched over 100 times. In total, videos were viewed over 19,000 times by the end of the end of June. The Global Platform website and corresponding social media channels (YouTube and Twitter) were updated before, during and after the event. 32,499 unique visitors viewed over 325,000 Global Platform website pages. e-Library: The Global Platform was again an occasion to call upon partners to update their disaster risk reduction profiles via PreventionWeb for inclusion in the 2013 e-Library. 1,000 organizations answered the call</p>

compared with approximately 300 during the previous platform. The 2013 e-library was developed by IMU including 5,000 organization profiles on their DRR activities, all 500 UNISDR documents, all 2007-2013 HFA reports (as of the Platform), all DRR related UN resolutions and reports 1962-2013, and the full 2009, 2011 and 2013 Global Assessment Reports. 3,200 USB keys were distributed, which saved 8,400 trees in printing and avoided 41,295 tons of greenhouse gas emissions.

Market Place, IGNITE and UNISDR Booth management: The DRR Market Place, IGNITE stage and UNISDR booths were managed and developed by IMU to showcase current and emerging trends in disaster risk reduction and served as key information and knowledge dissemination hubs. The 2013 Market Place was visited by each of the 3,500 participants at least once and featured 37 booths, many of them thematic and co-managed in partnership for the first time. The IGNITE stage featured 74 presentations, each reaching an audience of 30-50 participants. The UNISDR booth made all key UNISDR publications available to participants and demonstrated its websites (UNISDR.org, PreventionWeb and Making Cities Resilient), the GAR Tangible Earth display and 2013 e-Library. Regional platform websites and a corresponding regional registration system were designed and developed by IMU to help support promotion and participation in Regional Platforms for Disaster Risk Reduction. This conference website and registration system was designed, developed and launched as a scalable system for the first Arab conference on disaster risk reduction. The same model was requested and implemented for the fourth meeting of the European Forum for Disaster Risk Reduction (EFDRR).

Americas

Addressing HFA priorities in Action Plans.

ROAM has continued supporting the preparation of regional plans to advance in the implementation of the HFA priorities. ROAM contributed with comments to the preparation of the inter-agency document "Towards Sustainable Development: Latin America and the Caribbean in the post-2015 agenda" under the leadership of ECLAC. The document served as a regional input prepared as a basis for the inter-governmental discussions on the post 2015 SDG that took place in Bogota 5-9 March and explicitly addressed DRR as key component to be considered in a post 2015 SDG (<http://www.eclac.org/cgi-bin/getProd.asp?xml=/prensa/noticias/comunicados/8/49338/P49338.xml&pxsl=/prensa/tpl/p6f.xsl&base=/rio20/tpl/top-bottom.xsl>).

In the Caribbean in a dialogue with the Association of Caribbean States (ACS), ROAM supported the integration of Disaster Risk Reduction considerations in the outcome document of the "5th summit of heads of state and/or government of the association of Caribbean states "revitalizing the vision of the association of Caribbean states for a stronger and more united greater Caribbean". As a result, the declaration of Petion- Ville signed by 25 presidents and 4 associate states (see article 23 in <http://www.acs-aec.org/index.php?q=es/centro-de-prensa/comunicados/2013/declaracion-de-petion-ville>), explicitly incorporated DRR as a key priority for a joint strategy of the Caribbean nations and established an action plan for furthering its advancement in the Caribbean region. At the request of the ACS, ROAM also supported the subsequent design of the corresponding Action Plan (see point 4 of <http://www.acs-aec.org/index.php?q=press-center/releases/2013/plan-of-action-of-petion-ville>) which establishes specific actions at the regional level to advance in DRR .

In South America ROAM supported a high-level meeting of the Union of South American Nations (UNASUR) member states in April, in which high-level representatives proposed the creation of a High-Level Working Group on Integrated Disaster Risk Management (see attachment).

In Central America, through a Grant agreement with the Central American Coordination Center for the Prevention of Natural Disasters (CEPRENAC), UNISDR contributed to advancing the implementation of the Central American Policy on Integral Disaster Management (PCGIR) in the field of education and climate change adaptation. As a result,

the Ministers of Education of Central America approved DRR lines of action for the Education Sector 2012-2015 in the framework of the PCGIR. Furthermore, DRR and CCA have been incorporated within the Central American Regional Strategy of Climate Change. In addition, through a new Grant Agreement with CEPREDENAC signed in April 2013, CEPREDENAC carried out the II Consultative Forum of the PCGIR, with more than 250 representatives of national organizations of disaster risk management, technical institutions, international organizations, donors and civil society from 6 countries of Central America. As a result of this forum, the final declaration explicitly addressed the commitment of the member states to review and align the PCGIR with the post HFA in 2015 (see attachment-Foro Consultivo paragraph 4). ROAM promoted through letters addressed to national DRR authorities and CDEMA the inclusion of DRR aspects in the outcome document of the SIDS regional preparatory meeting for the Caribbean, 2-4 July 2013 in Jamaica, which was the region's input for the 2014 International SIDS Conference.

ROAM has continued supporting the National Platforms in the preparation of national plans to advance in the implementation of the HFA priorities. In Central America UNISDR in association with the International recovery Platform (IRP) and UNDP, ROAM provided technical support in the preparation of national recovery plans in the 6 countries of the region.

The countries in Central America have expressed their commitment for the approval of these plans once finalized and its further integration into the national plans for DRR. In South America, at the request of the Government of Chile, ROAM reviewed and prepared comments to the Civil Protection Law being discussed by the Chilean Congress. ROAM has also supported the preparation of the draft of the "Policy for Disaster Risk Reduction" being also discussed in the parliament. UN coordination for DRR. UNDAF At the request of the UNDG-LAC Peer Support Group, the ROAM has made an analysis of the current integration of DRR in the UNDAF in the Americas (see attachment) in order to prioritize the support to be provided to UNCTs in Roll-Out Countries in 2013. In 2013, ROAM as part of the United Nations Peer Support Group, supported the revision of the new UNDAF for Mexico, Nicaragua, the roadmap for Ecuador and participated in the UNDAF support training to the UNCT in Venezuela jointly with UNEP to integrate DRR in the UNDAF as per UNDG guidelines.

UN Action Plan for Resilience a. Within the UNDG LAC, UNISDR has supported the creation of a working group on resilience for the implementation of the UN Plan of Action on Disaster Risk Reduction for Resilience with the aim at supporting the roll-out and monitoring of the Plan of Action. During the incoming semester 013, UNISDR will continue with the identification of specific activities and commitments by UN Agencies in the Region through the working group.

3. Global Flagship events

ROAM promoted the region's participation at the GP13 and facilitated the organization of a Meeting of the Americas in the context of the GP. A guideline for representatives from the Americas was prepared to provide information on the main sessions, logistics, and overall orientation so that delegations can make the most out of it. The main results for the Americas region were: The number of participants from the Americas in the GP (more than 400) was higher than that of the last GP in 2011. It included government officials,

	<p>parliamentarians, mayors, NGOs, civil society organizations, academic institutions and private sector representatives. The biggest official national delegation was that of Brazil (47 delegates). The consultation meeting of the Americas held on 20 May in the context of the GP gathered more than 120 participants. The Guide for Participants from the Americas prepared for the GPDRR13 was presented during this meeting and welcomed by all delegates (see attachment). In the context of the GP three sub-regional consultation meetings were carried-out successfully (CAPRADE, CDEMA, CEPREDENAC) that discussed on the post HFA agenda and furthered the decision among IGO's in the region to carry sub regional consultations on the post HFA for the second semester of 2013. In addition, the ROAM facilitated and accompanied bilateral meetings between representatives of the Americas with Haitian representatives for furthering collaboration in DRR (Brazil, Chile, and Mexico).</p> <p>In 2013, ROAM has begun the organization of the fourth session of the Regional Platform. UNISDR obtained the agreement of the Government of Ecuador and the support from OFDA to host the meeting of the Americas from 27-29 May 2014 in Guayaquil, Ecuador.</p>
UNISDR Arab States	<p>Arab position on HHFA2 was developed and adopted at the 1st Session of the Arab Regional Platform. The recommendations of the region towards 2015 new DRR framework builds on progress on HFA implementation reported through national and local governments and challenges faced in advancing DRR in the region. An increasing number of Arab countries report on HFA implementation with improved recognition of HFA as a road map to enhance resilience at national and local level. In 2013, 11 countries reported on HFA and 8 cities reported on LGSAT.</p>
UNISDR Asia Pacific	<p><u>Implementation of national and sub-regional action plans to address HFA priorities</u></p> <p>The 2011-2013 HFA Monitor reports from 36 countries in Asia and the Pacific region indicate that most of countries have developed National Action Plans for DRR and are implementing them. About 7 countries indicated the development of national action plans for DRR during the biennium reporting cycle.</p> <p>Based on the 2011-2013 HFA progress reviews, Country Implementation Plans that integrate DRM and CCA were developed with technical support from the UNISDR Pacific Office for Cook Islands, Fiji, Samoa, Tonga and Vanuatu whilst eight other countries were done by the Secretariat of the Pacific Community (SOPAC Division). The EDF-10 funds, implemented through SPC (SOPAC) for the Pacific region with technical support from UNISDR Pacific Office were provided to countries for implementation of the Country Implementation Plans (bigger island countries were given €1,350,000 and smaller ones received €600,000). The development and implementation of Country Implementation Plans lead to the consensus on the development of the Pacific Integrated Strategy for DRR and CCA, the first of its kind in the world.</p> <p>ASEAN continues its implementation of two important regional roadmaps on Disaster Risk Assessment and Disaster Risk Finance and Insurance (DRFI). Regional Disaster Risk Assessment Forum and training organized for all 10 ASEAN Member States, academia and other ASEAN bodies. The ASEAN Cross-Sectoral Coordination Committee on DRFI has been established by the ASEAN Finance Ministers Meeting in April 2013 composed of ACDM together with the ASEAN Committee for Finance and Central Bank Deputies and Insurance Regulators as the implementation mechanism of the DRFI roadmap. Priorities for AADMER Work Programme 2013-2015 have been identified, emphasizing DRR. Agreement has been</p>

reached with ASEAN Secretariat and the World Bank on a new five-year cooperation and work is going on to identify specific areas of collaboration, drawing on a review of the ASEAN-UN Strategic Partnership and ASEAN-UN Strategic Plan for DRM

SAARC Member Countries continued to strengthen information exchange and knowledge sharing for DRR and CCA. A study on DRR- CCA integration in the SAARC region was completed as part of the action plan for implementation of the 'Thimphu Statement on Climate Change'. A Road map for GLOF risk mitigation in the SAARC region drafted for finalization in August 2013. SAARC consolidated sub regional report on HFA implementations progress for 2011-13 and identified of priority sub regional issues for HFA2

UNCTs and UNDAF that address DRR

Thailand: The first review of UNPAF 2012-2016 of Thailand reached agreement to develop strategy for UN agencies engagement in DRR in Thailand, also in support of Thailand hosting the 6thAMCDRR. The development of strategic interventions is in progress

Nepal: a video about the UNRC was produced, highlighting the importance of UN leadership in DRR

Afghanistan: SRSG mission resulted in agreement for UN-coordinated approach to support the Government of Afghanistan in developing a Short-term Action Plan to implement the Istanbul process

02 UNRCs from the region participated in the GPDRR13

Nauru: The draft Nauru UNDAF (2013-17) specifically addresses climate change adaptation and disaster risk reduction as an objective. This draft will be discussed in-country with the Government of Nauru in Mid-August 2013.

The Pacific Sub-Regional UNDAF (2013-17) - a five-year strategic programme framework - includes DRR and CCA as a specific output. The UNDAF outlines the collective response of the UN system to development challenges and national priorities in 14 Pacific Island Countries and Territories (PICTs), namely Cook Islands, Fiji, Federated States of Micronesia, Kiribati, Nauru, Niue, Palau, Marshall Islands, Samoa, Solomon Islands, Tokelau, Tonga, Tuvalu and Vanuatu for the period.

Regional Platforms – Preparation for 6AMCDRR

For the first time, the *Joint Meeting of the Pacific Platform on DRM and Climate Change Roundtable* was successfully organized in Fiji in July 2013 with UNISDR strong technical support. 260 people registered to attend from 21 Pacific Island Countries and Territories (PICTs) including the Caribbean and African countries. This represents a potential increase in participants by almost 70 people, with 190 participants of the Pacific Regional Platform on DRM in 2012. Pacific Platform technical sessions are being prepared by UNISDR raised the awareness of the role the private sector plays in making communities more resilient; and contributing to HFA2 consultations with the region.

The 1st IAP meeting of the year 2013 was attended by 140 participants from governments, international organizations, UN, academia and private sector. The meeting resulted in: 1) follow up on the 5th AMC DRR outcomes including monitoring of the delivery of commitments made by governments and stakeholder groups; 2) preparation for the 6th AMCDRR with provisions of inputs to the theme and sub-themes and required background studies 3) review of the regional synthesis of the 2011-2013 HFA monitor and reports and HFA2 consultations and 4) Asia Pacific approach and preparation for contribution to the 4th Session of the Global Platform on DRR; in addition to updates and sharing of knowledge and experiences on DRR.

For the first time, a public broadcast company Thai PBS attended the meeting and committed to play a big part in the next AMC meeting. 16 media organizations also signed for the first time an Annex media declaration committing to cover disaster risk reduction

issues. 15 representatives from the private sector also joined a side event meeting and made concrete commitments that enabled UNISDR to organize the Asia regional GAR launch with key partners from the tourism industry on 3rd June 2013.

Agreement has been reached with the Disaster Prevention and Mitigation Department (DDPM), the lead agency of the Government of Thailand to prepare for 6AMCDRR through a meeting with the Director General of DDPM on the possible theme and sub-themes for 6AMCDRR to be submitted to the National Steering Committee for 6AMCDRR. The concept note for 6AMCDRR is being finalized, highlighting regional inputs to HFA2 and the 3rd World Conference on DRR (3WCDRR) in 2015 as overarching goal of the conference.

Global Platform on Disaster Risk Reduction 2013

Asia Pacific region played a prominent role at the 4th Session of the Global Platform on DRR (GPDRR). 599 delegates from the region participated in the GPDRR, an increase by 66% compared to the 3rd Session of GP in 2011. 10 out of 42 delegations included non-governmental people. However, only 23% of the Government delegates are female – lower than the average of 29% globally. 12 Ministers from the region attended the GPDRR and contributed to the High Level Communiqué. Parliamentarians, mayors and President and CEO from AP were speakers at the Plenary and other sessions. Children from Tohoku Region in Japan who experienced the Great East Japan Earthquake and tsunami 2011 participated in GP and actively shared their views as DRR actors.

IGOs, National Platforms, national and local governments and stakeholder groups from Asia Pacific led or actively participated in the global consultations on HFA2, sharing the regional progress in implementing the HFA and views on a new global framework. All IGOs from the region organized briefing and discussions of Member States for coherent views and proposals.

14 bi-lateral meetings between delegations and delegates from Asia Pacific with SRSG and Sr. Managers of UNISDR as well as other partners were held at the GPDRR. A meeting was also held between Afghanistan, Pakistan and Kazakhstan delegates to take forward the implementation of the Istanbul Process Confidence Building Measures. Fiji indicated their desire to establish a National Platform for DRR, which would be the first in the Pacific region. New Zealand has also committed to preparing a paper on their experiences from the Christchurch earthquake of 2011 for other countries to take lessons from.

Inputs from Asia Pacific provided for a number of global publications. In addition, several reports/publications prepared by UNISDR AP Office served the discussions at GPDRR: Asia Pacific Regional Synthesis of HFA Progress Review 2011-2013, Asia Pacific Synthesis of HFA2 Consultations, Report on follow up to GP2011 Chair's Summary with observations from Japan on advancing several issues such as strengthened engagement in DRR by local government, women, children, as well as private sector in Japan. UNISDR AP also provided inputs to a number of partners' publications such as JICA Handbook for mainstreaming DRR through Kobe office.

World Conference on DRR 2015

UNISDR Kobe office coordinated the discussions with the Government of Japan (MOFA and CAO) toward 3WCDRR in March 2015 including a number of SRSG and high level UNISDR missions in the reporting period. On 14 May, the decision was made officially by the Government of Japan to hold WCDRR 2015 in Sendai city in March 2015 and the venue city was announced at the closing of the GP13. Continued discussions held between UNISDR and the Government of Japan (MOFA, CAO and Permanent Mission of Japan) to build common understanding with the host country regarding the possible dates for the conference, modality of the conference including a number of preparatory meeting/s and the timing/s and funding arrangement for the organization of the conference.

The Chair Summary of Global Platform 2013 highlights the need for multi-stakeholder commitments at the Global Platform and 3WCDRR for HFA2 implementation. Work has begun in the region to strengthen the stakeholder groups, established at 5AMCDRR

	<p>including dialogues between the groups and facilitation of stakeholder groups partnership with national and local governments.</p> <p>The communication AP office is a focal point for the conference and is already actively working on a communication plan.</p> <p>Supported and facilitated the continuous commitment from the Government of Japan to the international agenda on DRR and UNISDR which led to the Japan's offer to host the 3rd UN World Conference on DRR in early 2015. (GA Resolution 2012 decided to organize UN WCDRR in early 2015 in Japan). - New major partners from Japan including private sector from Japan were facilitated to join in and contribute to the initiatives through UNISDR (GP, Regional Platform and GAR), including Kokusai Kogyo, Development Bank of Japan, and Save the Children Japan (including children participations in Regional Platform) etc. They participated in GP, Asia Regional Platform, GAR and other important events by UNISDR. - Through facilitation, Japan has submitted the HFA National Progress Report 2011-2013 (interim version) by the deadline.</p>
UNISDR Bonn Office	<p>Strengthened engagement of UN agencies based in Bonn reflected in contribution to the development and promotion of the UN Action Plan on DRR for Resilience. Further discussions with UNCCD in Bonn led to ensuring collaboration on the Drought High Level Forum held in Geneva and in March 2013 to reflect DRR and risk management in national drought management plans. Discussions and guidance to UNV led to development of a UNV proposal (with funding from Japan) to strengthen support to UN RC offices in targeted countries for the implementation of HFA and the UN Action Plan on DRR. The project is expected to be approved in 2013 for implementation in 2014. UN Bonn participation at the GP2013 in Bonn was further enhanced from previous sessions including in side events organizations and contributions to GP events.</p>
Central Asia Sub-Regional Office	<p>3. 43 delegates of Central Asia and South Caucasus took part in the Global Platform for DRR in 2013. 22 representatives of the region took part in the Asian Ministerial Conference in Indonesia in October 2012. The Regional DRR Consultations in Almaty in March 2013 gathered 64 representatives of eight countries of Central Asia and Caucasus, Russian Federation, regional organizations. UNISDR/CAC supported the participation of the HFA Focal Point from Armenia in the 2012 European Forum for Disaster Risk Reduction (October 2012, Croatia) of which Armenia is currently a member. UNISDR/CAC supported participation of the inter-state TV company MIR in Global Platform 2013. The representatives of governments, non-government organizations, private sector, and mass media promote DRR in their respective countries and sectors.</p>
UNISDR DRR Coordination and Regional Programmes Section	<p>The Fourth Session of the Global Platform was delivered with 3,500 participants from 172 countries, including 168 official government delegations. Over 47 high-level participants, including 34 Ministers, attended the High-Level Dialogue. The Global Platform attracted many stakeholders from national and local governments, inter-governmental organizations, non-government organizations, mayors, parliamentarians, communities, the business community, academia and science, children and youth. Two-thirds of the participants attended for the first time, highlighting UNISDR's outreach taken so far. New focus groups emerged on that occasion, in particular persons with disabilities, the military community as well as partners involved in migration, resilient heritage and pandemics.</p> <p>The twenty substantive sessions organized at the Global Platform (including Plenaries, Informal Plenaries and Featured Events) provided a wealth of technical expertise and innovative ideas that brought a high sense of satisfaction and appreciation among panellists and participants. All sessions brought most renowned experts on the subject and ensured an equitable geographical and gender distribution so to ensure the highest quality discussions, the most fruitful exchange of experience and concrete substantive outcome. Overall 200 discussions took place throughout the Global Platform (including 27 side events and 44 preparatory events) focusing on practical solutions, new tools and methodologies to promote the understanding of and investment in disaster risk reduction, leading to an unprecedented cross-regional sharing of expertise and experiences and promises for the forging of new partnerships and alliances towards HFA2. The fourth session of the Global</p>

Platform represented a significant milestone in building up to HFA2 and benefited from intense on-site multi-stakeholder consultations and a Synthesis Report summarizing HFA2 consultations recommendations and priorities up to the Global Platform. The Global Platform came out with three major outcome documents, including a Chair's summary and a High-Level Communiqué from the High-Level Dialogue, that provide clear guidance and concrete recommendations for action towards post-2015 and beyond, including to deliver on commitments to risk reduction, particularly at the local level. A Synthesis Report on HFA2 was also produced that provides an overview and background of the issues emerging from the consultations and the priorities identified for the development of a post-2015 framework for disaster risk reduction (HFA2). Draft proceedings were developed and will be finalized by the end of the summer. The business community was heavily represented at and actively contributed to the Global Platform with the organization of one plenary session, a preparatory event, a simulation exercise and a strong private sector component and representation in four Featured Events and four side-events. A significant increase in the number of business delegates participating at the Global Platform, from approximately 30 in 2011 to 175 in 2013. The Scientific and Technical Advisory Group (STAG) was reinstated at the end of 2012. The group produced a STAG 2013 report and facilitated the organisation of two science related events at the 2013 Global Platform, thereby placing science and technology at the forefront of Global Platform discussions. The Chair Summary of GP13 has also acknowledged the role of science and technology in the public policy and practice of DRR. A STAG webpage has also been developed during the reporting period. The Global Platform built on the Regional Platforms discussions during which the DRR Section facilitated special sessions on HFA2 and the National Platforms Review for their information and contribution. The private sector organized a special roundtable for the business community at the Regional platform in Africa whilst three regional and international multinationals with significant business operations in Africa discussed the regional business case for DRR (<http://www.unisdr.org/archive/31267>). A draft guidance note on Regional Platforms promotes a standardized approach to Regional Platforms discussions was revised and shall be finalized by the end of the summer. A Regional Compendium was produced, providing the full text of 2012-13 Regional Platforms / Ministerial Conferences declarations / Agreements with a detailed analysis and key recommendations towards HFA2. The document was circulated to the entire DRR constituency and served as a basis for discussion at the IGOs consultation held on 20 May 2013 in the context of the 4th session of the Global Platform for Disaster Risk Reduction (19-23 May 2013, Geneva) to help define a coherent and standardized approach to DRR implementation at the regional level (whilst preserving regional specificities). On the UN front, 29 UN agencies, programmes and funds demonstrated they share common parameters for implementing disaster risk reduction in their country programmes and monitoring the impact of the work.

EFDRR: Europe Office hosted the EFDRR Friends of the Chair (formed by Norway (Chair), Spain (Co-Chair), Croatia, Germany, Italy, Council of Europe, DG ECHO and UNISDR). The meeting discussed the preparation of the next EFDRR meeting taking place 23-25 September 2013 in Oslo, Norway. During the 2013 EFDRR event, similar to the last one, 1 full day will be dedicated to the HFA2 discussion. Furthermore, it is envisioned to establish a new working group on reviewing National DRR Plans and possibly develop general guidelines on basic elements to be part of National DRR Plans. EFDRR Working Group on "Climate Change Adaptation and Disaster Risk Reduction" is composed of Germany (new Chair since 2013), Norway (previous-Chair), France, Poland, EC DG Climate Action, Council of Europe and UNISDR. During a meeting in January 2013, the work plan for 2013 has been agreed upon. The working group has finalized the first draft of report on the survey on how European Countries include in their climate change adaptation plans/strategy issues related to disaster risk reduction. This survey was conducted by the Norwegian Directorate for Civil Protection (DSB) on behalf of Working Group in 2012. 24 European countries have completed the survey and during 2013, the WG will develop a report based on the survey findings and the inputs from the Group members.

In 2013, EFDRR Working Group "Local level implementation of the HFA" joined by Italy (Chair), Austria, Sweden, Council of Europe, DG ECHO and UNISDR held several

teleconferences during the first 6 months of 2013 (25 February, 14 May, 16 May). During the Global Platform for Disaster Risk Reduction, the Working Group launched a survey assessing local DRR measures undertaken in EFDRR member countries. The results will be presented at the 4th Annual meeting of the EFDRR in September 2013. During the meeting, a representative from the City of Strumica will give a presentation on local level DRR measures. In addition, Sweden will give a presentation on "Swedish initiatives to promote research on DRR and implementation of research findings at the local level".

National Platforms: The Serbian Government has proclaimed the National Platform for Disaster Risk Reduction on 24 January 2013. The National Platform plans to hold three to four regular sessions annually with a provision for more frequent sessions should emergency situations arise. The activities of the National Platform are financed through the federal budget and the resources of the authorities that are members of the National Platform. In February 2013, Belarus announced its National Platform to UNISDR Europe. The Government of Bosnia and Herzegovina has launched of its National Platform on Disaster Risk Reduction through a regional event organized on 25-26 March 2013, to better reduce the vulnerability to disasters in Bosnia and Herzegovina. The establishment of Bosnia and Herzegovina's National Platform will further strengthen existing coordination on domestic disaster risk reduction initiatives and at the same time strengthen cross border cooperation on building resilience to disasters. During the launch, neighbouring countries with already functioning National Platforms have been invited to share their good practices and propose how respective National Platforms can work together in the future. On 11 April 2013: Vienna, Austria: i) Head of Office briefed National Representatives (line Ministers and representatives from local and regional level) on National Platforms and for viewing the engagement of Austria for the establishment of a National Platform. The event had over 100 participants from all line Ministers and local level administrations. Austria indicated that they are interested in moving ahead with the development of the NP; ii) Met with Dr. Michael Staudinger (HFA Focal Point and Director of the Hydromet Institute Austria). Dr. Staudinger indicated that Austria has expressed a strong will to move ahead with the development of the NP and expects for the process to be completed before the end of the year. Mr. Staudinger confirmed the participation of Austria to the GP (HFA Focal Point) and the EFDRR (HFA Focal Point + possible other attendance from Minister of Interior). Mr. Staudinger extended gratitude to UNISDR for their support and facilitation in having the participation from Norway, Sweden and Germany in the NP discussion whose participation was very beneficial. PLANAT will visit Austria next month to further discuss the functioning of their NP and common hazards; iii) The MOFA representative at the meeting indicated the wish from Austria to become more active in the collaboration with UNISDR building on the opportunity of the NP development and the relevance of the Austria contribution to DRR.

During the Global Platform of Disaster Risk Reduction (19-23 May: Geneva, Switzerland), 40 European VIPs have participated (1 President (Switzerland); 1 former President (Finland); 3 Ministers; 3 Deputy Ministers; 4 Parliamentarians; 20 Ambassadors; 10 City Officials; 5 Director General (Civil Protection); and 1 European Commissioner). UNISDR Europe Office organized the consultative meeting of the European Forum for Disaster Risk Reduction where the HFA Regional Monitoring Report for Europe 2011-2013 and the UNISDR Europe Annual Report 2012 were launched. Furthermore, UNISDR Europe co-organized the consultative meeting on Peer Review Process. On 21 May, a Letter of Cooperation was signed between the Italian Civil Protection and UNISDR. On the same day an Open debate on "Disaster Risk Reduction measures in South Eastern Europe" took place where also 2 Mayors signed up to the Campaign. The publication "Heritage and Resilience – Issues and Opportunities for Reducing Disaster Risks" was launched during the featured event on "Heritage and Resilience" on 22 May. Eight bilateral meetings were held between HFA FP and UNISDR Europe Office including Austria, France, Greece, Hungary, Portugal, Russian Federation, Turkey, Switzerland, and Council of Europe. In relation to the Campaign: possible city-to-city exchanges between Montenegro and Portugal, Italy and Gaza and/or Egypt, Portugal and Sweden, Italy and Sweden were discussed. UNISDR Europe Office is part of the European Commission FP 7 funded "Enhance-project". UNISDR is responsible for

	<p>dissemination and communication of project results. The project aims at developing and analysing new ways to enhance society's resilience to catastrophic natural hazard impacts. The project will develop new multi-sector partnerships (MSP's) between public and private sector, with a role for the financial sector (e.g. insurers). The consortium consists of 24 partners from 11 countries and will last for four years and started in 2012. Europe Office shared the project brochure and information on the project through the monthly e-bulletin, at the Global Platform during the Enhance presentation at the IGNITE-stage and furthermore through the EC Commissions information booth at the GP. Europe office also contributed to the Enhance communication plan. Europe Office participated in the Enhance Kick-off meeting in January 2013.</p> <p>Under the implementation of the UNISDR-WMO project "Building Resilience to Disasters in the Western Balkans and Turkey": Increased DRR institutional capacities and coordination mechanisms through: ü The recruitment of an international expert who designed the survey and interviews' structure for the case analysis of an exchange programme among EU and IPA countries. The interim result is the development of an action plan for the exchange in which specific CCA and DRR topics for each beneficiary were identified through a participatory approach. The topics identified in relation to the national DRR agendas defined per HFA priorities. ü Between January and June 2013, the (National Protection and Rescue Directorate (NPRD) exchanged with the United Kingdom (Civil Contingencies Secretariat (CCS) and Montenegro (Sector for Emergency Management of the Ministry of Interior) exchanged with Portugal (National Authority for Civil Protection). Reports and assessment of the exchanges have been performed and will be included in the final report of the exchange programme. The participants were awarded by UNISDR a certificate attesting their participation in this on-the-job capacity building activity.</p>
UNISDR Korea Office	<p>Mainstreaming Adaptation and Disaster Reduction into Development (MADRID) programme: Three cumulative Leadership Development Forums (LDF's) convened in 2012 brought together multi-stakeholder teams of professionals from government institutions responsible for DRR, CCA, Development and sectorial planning and training- in total more than 140 high level government officials and parliamentarians from 14 countries and 10 International Organizations. Participants were involved in both the design and delivery of training material which built on national and international expertise in mainstreaming from around the world. Through the MADRID programme, participating countries representatives developed capacities for mainstreaming and enhanced the high-level DRR advocacy nationally and regionally and developed concrete action plans with commitments to follow-up in their home countries. Many countries have already have included MADRID programme in their 2013 work plan and started to reach out regionally with MADRID modules.</p> <p>Following examples illustrates the impact of the programme in participating partner countries: 1) In Armenia, MADRID material has been used as the basis for national training through the government run State Academy for Disaster management; 2) In The Gambia, MADRID Material was used to brief Permanent Secretaries from key government ministries resulting in new commitments for coordination in country; 3) In Lao PDR, MADRID discussions informed briefings of the national parliament and contributed to a focus on DRR in a joint dialogue held between Asian and European parliamentarians in Vientiane; 4) In Cambodia, MADRID dialogues informed the National coordinating committee for Climate change and the national planning process for 2014; 5) In Mongolia, Mongolian NEMA and the UNCT have cooperated to foster coordination between related ministries and institutions. Fresh Perspectives for the Future of Disaster Risk Reduction and Climate Change Adaptation: A consultative meeting on Cultural Heritage and Resilience (CHAR) was held on 29-30 August 2012 with about 20 specialists from the International Council on Monuments and Sites (ICOMOS) and its International Committee on Risk Preparedness (ICORP), UNESCO World Heritage Centre, UNESCO China, IUCN- the World Conservation Organization, the International Centre for the Study of the Preservation and Restoration of Cultural Property (ICCROM) and the Association of Korean Cultural and Historical Geographers, UNISDR and other participants. 1) At the meeting Participants examined the</p>

	<p>value of cultural heritage and agreed that at its core, cultural heritage is essential to sustainable development. In addition to the clear economic values associated with tourism and traditional livelihoods, heritage is a source of social cohesion with symbolic significance that promotes shared identity. Historical knowledge is a source of both inspiration and innovation in facing future challenges. The group considered the important connection between cultural heritage and natural heritage; 2) Discussions laid the foundation for further elaboration of a wider framework that establishes the protection of diversity as an essential feature of resilience.</p>

guidance being developed by UNISDR in preparation of the Global Platform.

From January to June 2013, the SRSR conducted 36 missions to 28 countries in 5 regions where she consistently met with a wide cross-section of ministries and other government bodies to hear from and exchange information on national progress towards HFA implementation. In the first six months of 2013, the SRSR held meetings around the world with approximately 46 Government Officials that included parliamentarians, local government officials, and ministry officials from finance and planning, agriculture, fisheries, rural development, urban development and infrastructure. In addition, the SRSR met with organizations active in their country's respective National Platforms, such as youth movements, women's groups, the National Society of the Red Cross and other civil society organizations. At the Global Platform, the SRSR held additional meetings with approximately 50 Government Officials across sectors such as civil defence, economics, defence and urban development. At the HOG/S level, the SRSR received a visit from the former President of the Republic of Finland and visited the VP of Nigeria, with whom she raised the issue of enhanced DRR coordination within nations.

History spanning six years beginning with the 14th and 16th session (2007 and 2008) of the High Level Committee on Programmes (HLCP), where its members discussed mainstreaming disaster risk reduction in the policies and strategies of the United Nations. The subject gained additional traction when the SRSR addressed the United Nations Chief Executives Board for Coordination (CEB) at its 2011 Spring Session. Following the decisions of the CEB, the SRSR convened, through the HLCP a senior management group to prepare a United Nations Action Plan on DRR for Resilience, which was ready in 2013. The SRSR worked in the first quarter of 2013 to gain UN CEB approval of the Action Plan, which was approved in April. This Action Plan will enable UNISDR to coordinate activities such as "training the trainers" among others, in support of UNCT efforts to help countries implement the HFA. At the SRSR's suggestion, the DSG convened a UN leadership meeting in May 2013 to discuss the Action Plan, attended by 26 UN executives of funds, agencies, programmes and Resident Coordinators which helped UNISDR gain the crucial support of the DSG and other high-level UN officials.

A Synthesis Report summarizing key HFA2 recommendations and priorities identified on the occasion of HFA2 consultations was produced and submitted in support of the 2013 Global Platform's HFA2 formal discussions (formal Plenaries, Featured Events and preparatory consultations) and Informal Plenary Sessions. Key elements relating to HFA2 that emerged from the Regional Platforms discussions were reflected as part of the 2013 Regional Compendium produced for the 2013 Global Platform. Several bi-laterals on HFA2 took place and four briefings on HFA2 were delivered to the UNISDR Support Group. Specific guidance on HFA2 was also provided in support of the development of the UN Action Plan for Disaster Risk Reduction.

Two HFA2 Advisory Group meetings were organized over the reporting period and worked on a number of work streams, including the DRR indicators and the future of risk. They advised the SRSG on a number of issues related to the HFA2 and supported the preparations for Informal Plenary discussions on HFA2 at the 2013 Global Platform. The members actively participated in the Global Platform and personally reviewed a number of the HFA2 consultations and national statements elements on HFA2. The International Recovery Forum January 2013 in Kobe included a special session to discuss national government recommendations for the post 2015 framework for DRR. Over 40 countries participated. The discussions focused on the need for more emphasis on the opportunity from recovery for building back better.

The recommendations are reflected in the meeting report, which includes a strategy for dissemination of the recommendations for the post 2015 framework. UNISDR also provided guidance on HFA2 on the occasion of thematic consultations linked to disaster preparedness, pandemics, migration, military and animals in disasters thereby reaching out to new groups of interest for disaster risk reduction.

As a result of continued guidance on HFA2 and contribution to the work of the Global Alliance for Disaster Risk Reduction Knowledge and Education (2013 March meeting on the UN Decade on Education for Sustainable Development, Geneva and April Global Alliance meeting, Paris), UNESCO recognized Disaster Risk Reduction Education as a major component of Education for Sustainable Development (ESD) and offered to organize a session on Disaster Risk Reduction Education at the World Summit on Education for Sustainable Development (November 2014, Japan). It was agreed that ESD would also be mainstreamed as part of the World Conference on Disaster Risk Reduction discussions (March 2015, Japan) so to reinforce the mutually-supportive character of ESD and Disaster Risk Reduction Education.

UNISDR
Europe Office

In January 2013, UNISDR Europe presented the HFA 2 consultation process at the Head of Agencies meeting in Brussels and to the UN Brussels Team Policy Group. EUR-OPA, Council of Europe, will feature the HFA2 discussion within the Permanent Correspondence meeting to be held on 28-29 October 2013. EUR-OPA is currently discussing with the Chair (Croatia) on the organization of the Ministerial Meeting around the following 2 possible scenarios: a) Organization of the EUR-OPA Ministerial Session in spring 2015. This will allow for the EUR-OPA to set their 4 year work plan in line with the adopted HFA2; b) Organization of the EUR-OPA Ministerial Session at the beginning of 2014 to provide views on the HFA 2.

On 27 March 2013, UNISDR organized a breakfast briefing on the HFA 2 in the European Parliament hosted by the Committee for Environment, Public Health and Food Safety ENVI. The event featured Members of the European Parliament (MEP's) from several Committees, the European Commission (DG ECHO and DG Climate Action), NGO representatives and EU Countries Permanent Missions. MEP Mr. Gay Mitchell, Committee for Development (DEVE), announced that he has been appointed as rapporteur in the DEVE Committee for an Own-Initiative Report on DRR, resilience and the HFA 2.

Mr. Mitchell will host a Parliamentarian Exchange of Views on DRR and the HFA 2 in September 2013 featuring the SRSG and EU Commissioner Kristalina Georgieva. Mr. Mitchell is also part of the UNISDR Parliamentarian Advisory Group. The European Commission Inter-Commissioners breakfast meeting on the HFA 2 took place on 10 April in Brussels, Belgium. Participating Commissioners were Commissioner Connie Hedegaard (DG Climate Action), Commissioner Michel Barnier (DG Internal market and services), Commissioner Máire Geoghegan Quinn (DG Research, Innovation and Science), Commissioner Andris Piebalgs (DG Development) and Commissioner Janez Potočnik (DG Environment).

Senior level representatives also participated from DG Home, DG Agriculture and Rural Development, DG Regional Policy, DG Financial Programming and Budget, DG Sanco and the External Action Service. The debate focused on ways to pursue and strengthen disaster risk management policies and activities as part of the EU growth and competitiveness agenda, and on the priorities to be addressed in the post 2015 Hyogo Framework for action, in synergies with the post 2015 development agenda and the follow-up to Rio+20. ü Ministers for Foreign Affairs of the South East Europe Cooperation Process (SEEC) have met in Ohrid, the former Yugoslav Republic of Macedonia, on 31 May 2013 at the Formal Meeting of the SEEC Ministers for Foreign Affairs to discuss disaster risk reduction and climate change adaptation. The Ministers of Foreign Affairs agreed on a Joint Statement “Solidarity in Action” where they are giving recognition to the Hyogo Framework for Action and are requesting the enhancement of regional cooperation to further strengthen the capabilities of SEEC participating states for disaster risk reduction and climate change adaptation.

Furthermore, the Minister’s signed a Declaration where they also considered that disaster risk reduction and climate change adaptation is of utmost importance to all SEEC Participating States and confirmed that on-going and follow up activities should be directed towards the development of concrete initiatives. Increased coordination and improved coherency in European policies vis a vis DRR and climate change adaptation through the participation of UNISDR at the UN Brussels Team Policy Group and contribution to relevant EU Consultations. During the first six months of 2013 the following consultation “EU Fit for the Purpose”, the EU “2015 International Climate Change Agreement: Shaping international climate policy beyond 2020” and – through the ENHANCE project Consortium, UNISDR prepared the policy response to the EU Green Paper on the insurance of natural and man-made disasters.

In March 2013, the German National Platform DKKV has submitted Germany’s preliminary report on the HFA2 consultation. The report was drafted in a consultative manner together with 6 members of the DKKV. The document should serve as a first draft in order to indicate the major topics important to the German National Platform. A more comprehensive document is planned to be published in the course of 2013. HFA2 national consultation was undertaken in Norway.

A report summarising the findings of governments over three cycles of progress review to 2013, was produced and disseminated at the GP13 as a comparative stimulant for inter-country dialogue.</p> <p>The inaugural HFA Peer Review was completed in the UK, the report of which was approved by the UK government and presented to the Minister for use in strategic planning and priority setting. UNISDR Advocacy and Outreach Section	<p>Raised awareness among local chief executives on the importance of disaster risk reduction action at the local level through high-profile local and national sign-up events. More than 1,400 cities and local governments have “signed up” to the Campaign by July 2013.</p> <p>Identified a dedicated group of local Champions willing to share their experiences and sound practices on local disaster risk reduction implementation. At present there are thirty-nine Role Model cities have been designated, as well as 10 individual Champions, who have pledged to lend their support to promote the campaign objectives among their peers. In addition, UNISDR is nurturing a network of dedicated professionals and promoters as Advocates of the making cities resilient. Two new champions have been nominated Mayor of Mashhad (Iran) and Mayor of Tevragh Zeina (Mauretania) and 11 new advocates have been appointed in 2013 to date (list of advocates upon request).</p> <p>4 partnership agreements have been signed with: the Center for Geo-Morphological Integrated Analysis in Mediterranean Area (CGIAM); SES consultancy; Sancti Cirilly University from Malta and the Association of Construction Engineers from Iran.</p> <p>More than 100 Mayors including representatives attended the 4th Session of the Global Platform. A Resolution of Mayors and Local Authorities to build Resilience in Latin America was signed at the margins of the global platform.</p> <p>Since April 2013, 137 new cities have joined the campaign amongst which Hoboken (New York), Campinas (Brazil), Malmö (Sweden) and Barcelona (Spain) have been designated as Role model cities and cities from Afghanistan, Albania, Korea, Montenegro, Turkey, Palestine and 90 municipalities from Honduras have joined the campaign.</p> <p>Mayor Al’s (from San Francisco, Philippines) resilience road trip in Central America recently highlighted the outreach and impact of the Campaign. Mayor Al a designated champion of the campaign whose city won the 2011 Sasakawa Award for Disaster Risk Reduction, spent five days journeying across Central America to exchange information with local authorities on best practice to make urban settings safer from natural hazards. He set out on May 2 on a journey through Central America that took him to the cities of Quezalguaque, (Nicaragua), Marcovia (Honduras) and Santa Tecla, (El Salvador) where he joined efforts with Campaign Champion Oscar Ortiz from Santa Tecla (El Salvador). The central government of Nicaragua highlighted that these exchanges assist local governments in identifying the gaps and learning from others, raising awareness on DRR issues at the local level and exchange of good practices and lessons learnt that strengthens relations among neighbour countries in Central America.</p>

The second steering committee and partners meeting (first meeting was in 2011 December) was hosted by city of Barcelona from 1-4 April 2013. More than 40 cities and partners participated in this critical meeting, where the future strategy was discussed, flagship products of the Making Cities Resilient Campaign and the role of steering committee was deliberated and agreed. Two regional Advisory Groups have been set up during this period: one in Latin America and one in Asia Pacific. Both groups have elected chairs, agreed to a two-year Action Plan, and made group as well as individual commitments.

The Advocacy Team continued to provide technical support to the Committee on Social Affairs, Human Exchanges, the Environment, Education and Culture of the Euro-Latin American Parliamentary Assembly (EuroLat). At the VI Plenary Meeting of EuroLat, the Assembly adopted on January this year a resolution on Prevention of Natural disasters in Europe and Latin America. The Resolution calls for greater leverage for disaster risk reduction as a part of development plans, goals, and targets in the successor to the Millennium Development Goals post-2015. It urges governments to include risk reduction when planning public investment, urban developments, and environmental planning and management and to allocate sufficient funding for this purpose in their budgets. It also stresses the particular importance of including the risk of disasters in the construction sector and recommends full cooperation between the two regions to prevent and mitigate their impact of disasters, through the exchange of best practices and risk information, adaptation and capacity-building programmes, transfer of more appropriate technologies, financial aid, the strengthening of governance, particularly in organizational, legal and political terms, and the improvement of early-warning systems.

Further to the VI Plenary Meeting of EuroLat, a message from the EuroLat to the first CELAC-EU Summit of Head of States brought attention to disaster risk reduction, the message urged greater cooperation and sharing of information and best practices on disaster risk reduction with a view to drawing up and implementing risk prevention strategies. As result, the EU-CELAC Action Plan 2013-2015 identified the need to strengthen bi-regional cooperation activities in the field of disaster risk reduction and management, including by increasing the knowledge of the problems and the importance of integration of DRR and CCA in the development strategies and policies.

The Global Advisory Group of Parliamentarians launched the Policy Guidance note for Post-2015 Governance for Disaster Risk Reduction as agreed in the Advisory Group Meeting held in March 2013.

128 IPU Assembly (Quito): Disaster Risk Reduction was on the Agenda of the 128th IPU Assembly. MPs emphasized the importance of early parliamentary involvement in the negotiation of new agendas and added that disaster risk efforts would be furthered if parliamentarians followed through at home on the matters raised during the panel discussion of effective risk management. UNISDR emphasized the link between good governance and disaster risk reduction and development. Strong institutional and legal framework for development planning that account properly for risk reduction were identified as central elements of good governance.

As a result of the Advocacy efforts from the Advocacy Team and the Champion for Disaster Risk Reduction at the Geopolitical Groups of the IPU, the IPU member Parliaments decided to formally place on the agenda of their Standing Committee on Sustainable Development, Finance and Trade, at the next 130th IPU Assembly, the issue entitled "Towards risk-resilient development: Taking into consideration demographic trends and natural constraint". The IPU will debate this topic, and begin to identify specific recommendations for parliamentary action. This will serve as the basis of negotiations on a resolution to be adopted in the spring 2014. Monitoring tools will be developed to ensure effective implementation. Additionally the IPU will mobilize a robust parliamentary contribution to the process leading up to the post-2015 framework for DRR.

	<p>Members of the Global Advisory Group of Parliamentarians agreed to promote the integration of disaster risk resilience into the Post-2015 Development Agenda, framing it as an issue of vital importance for sustainable development. MP Gay Mitchell, MEP raised the issue of DRR and resilience at the Development Committee meeting in the European Parliament. The Lithuanian Vice-Minister of Foreign Affairs, responsible for development cooperation policy, presented the priorities for their incoming EU Presidency. Mr. Mitchell requested that priority should be given to DRR and its place on the post-2015 development agenda.</p> <p>MPs also agreed to promote governance as a critical issue for parliamentarians to act on, therefore they have launched a concept paper on Governance for Disaster Risk Reduction at the 4th Session of the Global Platform for DRR. MPs also agreed to increase participation in the 4th Session of the Global Platform, especially at the IPU-UNISDR parliamentarian consultation on the post-2015 Framework for DRR . Expansion of the parliamentarian’s network is making headway. Parliamentarians have been very active in identifying new members of the Regional Advisory Groups through the IPU Assembly. Four new members were identified from Namibia, Tanzania, Rwanda, Chile and Costa Rica.</p> <p>1st reading of the Draft Model of Legislation took place at the Parliamentary House of the East African Legislative Assembly. The Advocacy Team together with members of the African Advisory Group and has provided technical assistance to the draft model of legislation. Additionally, the advocacy team provided technical and logistical assistance for the preparation of public hearings in Uganda, Rwanda, Burundi and Nairobi.</p> <p>At the request of a member of the Regional Advisory Group for LAC, the Parliamento’s Committee of Environment agreed to the submission of a draft protocol for DRR at the next meeting of the Assembly.</p> <p>12,326 unique Making Cities Resilient website visitors viewed just over 63,000 pages and benefited from a streamlined sign-up process, an enhanced events calendar, reading list, city profiles, role model cities map and social media integration to improve the visibility of participating cities and promotion of their activities in disaster risk reduction facilitated by IMU website feature design, development and content management support.</p>
<p>UNISDR Americas</p>	<p><u>Participation in the campaign</u></p> <p>During the first semester of 2013, almost 90 cities from 8 countries have joined the making Cities Resilient Campaign, committing to implement at least one of the 10 essentials in their planning and development processes, bringing the total number of cities participating in the campaign in the Americas to 350 (115 have still to complete relevant documentation). Campaign launches and promotional events organized by ROAM in Costa Rica (February), El Salvador (April), Panama, Jamaica and Nicaragua (May) and Honduras (June) have been a great incentive for cities to sign off to the campaign. In total 112 cities joined the campaign during June. Among them, it is worth highlighting the cities of Medellin, Colombia, nominated in 2013 as the most innovative city in the world and host of the World Urban Forum in 2014; and the City of La Plata, Argentina.</p> <p>As a result of the collaborative efforts with the Government of Brazil, through the Excellence center for DRR, the first semester of 2013, 12 additional cities have joined the campaign thanks to the promotion and encouragement offered by the municipality of Campinas. The municipality of Campinas has been recognized as a Campaign “Role Model”. upon the priorities and national indicators of the Hyogo Framework for Action. 17. Collaboration agreements

Since January 2013, 2 collaboration agreements have been signed to promote the building of resilience at all levels using as vehicle the Making Cities Resilient Campaign: 1 in Jamaica with the Ministry of Local Government & Community Development, Office of Disaster Preparedness Emergency Management ODPEM and UNISDR, and 1 in Panama with the Association of Municipalities AMUPA.

ROAM has established the nomination of the “municipality of the month” in UNISDR’s regional web site inviting local governments participating in the Making Cities Resilient Campaign to create and/or update their city profiles to clearly show their areas of expertise and need. The “Municipality of the month” initiative has now published 2 city profiles (Campinas in Brazil and Pasto in Colombia). Local governments are showing interest and more want to take part. The municipality of the month for June will be Portmore in Jamaica. See the current municipality of the month.

City-to-city exchanges

In January 2013, ROAM launched a call to promote the exchange of experiences on DRR and CCA among municipalities. As a result, during the first semester of 2013, two city exchanges between role model city of Santa Tecla (El Salvador) and Anse-à-Galets (Haiti) and Lampa (led by the Campaign Champion Graciela Ortuzar in Chile) and La Paz (Bolivia) were implemented. The exchanges have allowed more long term cooperation agreements, particularly in the experience of Haiti, where Santa Tecla has continued providing cooperation. The Call to experiences launched by ROAM, has allowed identifying since January 9 additional cities committed to participate in the exchanges involving 9 local governments that will be supported by ROAM during the period July-December 2013. The first of these exchanges between the city of Cartago (Colombia) and role model city of Santa Fe (Argentina), took place in July 2013.

The cities that will be carrying out the other three exchanges until December 2013 are: Role model city of Portmore (Jamaica) – Town of View Royal (Canada), Pasto (Colombia)- Tegucigalpa (Honduras), Wiwilli (Nicaragua)-Livingston (Guatemala)-Cantarranas (Honduras). Following the experiences among cities in the Americas, ROAM has initiated the design of a scheme to promote the exchanges among municipalities within a Country. The first of these encounters was organized in Peru to promote exchange of experiences among Mayors of the Lima Province in alliance with a National DRR Civil Society organization. The success of this experience within a country, has allowed identifying a new set of exchanges to be promoted by ROAM in alliance with national municipalities for the second semester 2013.

Since 2010, in association with ILO/DELNET, ROAM has been promoting the training course on local sustainable development, DRR and climate change adaptation. This eight-month-long course is offered under a virtual platform and includes a two-week residential segment at the UN Training Centre in Turin. Since the beginning of this initiative, 250 professionals from Latin America have been trained thus far. The course has been adapted and is currently available in Spanish and Portuguese. The possibility of organizing future residential segments of this course in the region to reduce its cost was discussed with ILO officials and will be further explored.

ROAM jointly with UN-Habitat, developed a training course on DRR policies and the 10 campaign essentials oriented to local authorities. The module was tested in Chile where 22 municipalities in the basin of the Bio river participated. The module is being translated into English in association with GETI to be applied in similar experiences in Asia.

<p>UNISDR Asia Pacific</p>	<p><u>Resilient Cities Campaign</u> More than 10 cities and local governments in Asia and the Pacific joined the Campaign during the reporting period including 4 major cities in Korea. Improved organizational structure, management bodies tasked to steer strategic direction (SLG) and closely coordinate programme oversight (Operations Management Group, Programme Monitoring Group, Programme and Finance Committee) and enhanced accountabilities have already been achieved through implementation of these recommendations, while the remaining ones have been internalized in the UNISDR corporate implementation plan.</p> <p>Finally, dedicated support and guidance to all units/offices continue to be strengthened to enhance operational capacities, process ownership/familiarity and programme effectiveness. Specific progress achieved across work areas is detailed below. Result Based Management System Implementation of Result Based management System in UNISDR has resulted in improved planning and implementation of its activities. UNISDR has adopted an RBMS approach throughout the programme cycle, spanning from planning, implementation, monitoring and review of its biennial work programme. UNISDR has enhanced the online e-Management Tool (e-Tool) accessible by all its units/offices, with a view for this to progressively become the integrated IT platform that would link with UN official tools and allow for coherent financial and programmatic planning, monitoring and implementation of activities.</p> <p>This was undertaken at the recommendation of an external assessment of Administrative and Financial services completed in January 2012 and has allowed UNISDR successfully carry out a Result Based Budgeting exercise in last quarter of 2012 and the for 2013 Cost Planning process. Similarly, periodic result based monitoring and reporting is being done through the e-Tool.</p> <p>UNISDR also adjusted its Strategic Framework and Work Programme 2012-2015 by improving focus on the Results and achievements attributable to UNISDR's work. This has resulted in improved understanding of intended targets / results across units, enhanced focus and related prioritization of capacities and improved synergies between</p>

headquarters and regional activities. Some of the indicators were also adjusted for improved reflection of UNISDR's achievements.

Financial Management put into action the SRSR request for more transparency on the financial and budget allocation process. As result, monthly financial reports and resource allotments for all cost centres were systematically posted on the intranet for easy access by all staff and managers. This achieved more proactive way of doing business and a financial-management culture based on increased accountability and decision-making capacities for programme managers. Several financial and budget processes, such as the allotment, were streamlined and accelerated in result of the external finance and admin process review, in line with OIOS' recommendations. This allowed the production of monthly integrated information to management on resource needs and cash flow forecasts, based on which resources were programmed and monitored/reported.

Progress was also made towards automating the budget and finance modules of the e-management tool. Prior to the automation of the budgeting process in October 2012, results based budgeting briefing session was held during the all staff retreat in September 2012. In December 2012, the allotment module of the tool was launched and will be further enhanced in 2013 to accommodate IMIS and Atlas automatic data feed.

UNISDR also organized mandatory IPSAS basic online training for all staff with admin and finance functions, to ensure capacities are in place to allow for the smooth transition to IPSAS in 2013. Human Resource Management In 2012, provided staff administration services to seventy six staff members to ensure the continued delivery of the departments work programme.

HR/EO extended support to the process of selection and recruitment of four Senior Managers. These positions are critical pillars for the overall management structure of the department and to the strategic and policy development requirements. The introduction of the new e-performance management system in 2012 involved training and support from the HR/EO. The training and support has resulted in sustainable and efficient performance management system for staff and the organization. The engagement of consultants and individual contractors allowed the department to support substantive offices in delivering on ad-hoc requests at both headquarters and at the regional level.

UNISDR also proactively oversaw the human resource administration by other service providers to UNISDR, such as UNOPS, UNDP etc. Finally, EO guided staff in application of UN rules/guidelines and proposed relevant policies and guidance to senior management with regard to mobility, regularization of positions, enhancing recruitment skills, performance management guidance, etc. Administration In 2012, the UNISDR Grant Committee was established including Terms of Reference and Standard Operating Procedures.

Twenty three (23) grants were issued, amounting to 9% of 2012 total expenditure. Grants to partners resulted in the production of credible evidence. The administrative/support services have been providing day-to-day operations, support to regional offices, advice and oversight. Focus areas of work included rolling out the UN Secretariat staff selection system INSPIRA, recruitment, UNISDR induction package, monitoring of the Human Resources Action Plan, trust fund management and travel and logistics. Guidance on travel procedures, most specifically for workshops, was provided to colleagues worldwide. This resulted in enhanced planning and more effective processing of travel for workshops allowing colleagues to focus on substance.

UNISDR proactively participated in IPSAS preparations with the United Nations Office of Geneva, and reported on non-expendable property; reports will be incorporated in the greater UN financial reporting. Guidance on drafting partnership agreements resulted in memorandums of understanding with partners for DRR. Staff training and development

	was undertaken resulting in enhanced human resource skills and capacities in disaster risk reduction, communications, project management, and leadership.
