ISDR Asia Partnership (IAP) meeting of 2016 Bangkok, Thailand 21-22 June 2016

Venue: Amari Watergate Hotel, Bangkok, 6th floor, Ball room C

The ISDR Asia Partnership (IAP) meeting of the year 2016 will be held on 21-22 June in Bangkok, Thailand in association with Government of India as the host of the AMCDRR 2016. The main focus of this IAP will be to discuss the substantive and logistical preparation of the Asia Ministerial Conference on Disaster Risk Reduction (AMCDRR) 2016 to be held in New Delhi on 02-05 November 2016.

Background:

The IAP is an informal multi-stakeholder forum with the role of facilitating the implementation of the Hyogo Framework for Action 2005-15 (HFA) and now the Sendai Framework for Disaster Risk Reduction 2015-2030 in the Asia region. The IAP has been the main consultation forum for the Regional Platforms (AMCDRR) in Asia. The partnership comprises a wide range of multi stakeholder members that includes representatives of national governments (mainly HFA/now Sendai Framework focal points), organizations that are part of the key stakeholders groups, sub-regional inter-governmental organizations, international financial institutions (IFI), bilateral donors, UN & international organizations, civil society organizations, media and so on.

The AMCDRR in 2016 will be hosted by the Government of India in collaboration with UNISDR. Governments and partners have been continually engaged in its preparation through the IAP. The IAP members were consulted in the June and November 2015 sessions on the structure and content of the AMCDRR 2016 and the main outcome document, the 'Asia Regional Plan for Implementation of the Sendai Framework'.

During the IAP meeting in June 2015, consensus was reached on the expected outcomes of AMCDRR 2016. This included: 1) a political declaration; 2) adoption of a Regional roadmap/ plan for Sendai Framework implementation; and 3) statements of commitments from governments and stakeholders. Following the June 2015 meeting, an Asian Leaders' meeting towards implementation of the Sendai Framework for Disaster Risk Reduction in Asia and a 2nd IAP meeting of 2015 was held in New Delhi on 17-19 November.

Based on the previous two IAP meetings (December 2014 and June 2015) and as directed by the members of the IAP, the UNISDR secretariat prepared a pre-zero draft of the Asia Regional Plan which was shared with IAP members at the November meeting. IAP members provided extensive comments during the meeting and continued commenting (by email and phone) until Jan 2016. This resulted in a substantial revision of the pre-zero draft document. The IAP meeting in November 2015 also agreed to establish working groups to further consult and develop the Asia Regional Plan. Three advisory working groups (public, private and local) were established with voluntary participation of experts from governments, private sector and the local level.

Based on the inputs and comments from the IAP members and the advisory working groups, the 'Asia Regional Plan for Implementation of the Sendai Framework' was revised and structured around: a) Broader **policy guidance** towards setting a direction for implementation of the Sendai Framework in the regional context; b) **long term road map**, spanning the 15-year horizon of the Sendai Framework outlining the implementation pathway with intended results setting the focus; c) **two-year action plan** with specific activities and achievable targets by the public and private sectors as well as local actors (*the two year timeline coincides with the biennial Asia Ministerial Conferences that will provided an opportunity to review and revise the plan in a periodic manner*).

The substantive and logistical preparations of the AMCDRR 2016 are at an advanced stage, requiring further consultation with governments and partners in the IAP for final consensus.

With the above background and the upcoming requirements of the regional consultation on the AMCDRR 2016, the **main objectives of this IAP** will be to:

- 1. Update on the substantive, administrative and logistical preparations of the AMCDRR 2016
- 2. Present and discuss the revised version of the Asia Regional Plan for Implementation of the Sendai Framework
- 3. Identify and discuss the key elements of the political declaration of the AMCDRR 2016

Expected participants will be the wide range of multi stakeholder members listed above.
